### **Call to order**

- e) Booster Club Cookout – plan for an end of the season cookout on June 23, start at 11am. Location still not determined – potential for Cottonwood Park. Curtis will check on reservation. Melinda will send out invitation for RSVPs.
- f) Order shirts – Melinda working on new shirts. Questions from vendor on type of shirt and size of the logo. Need approval from Bucs front office of design.
- g) Scholarship – set and respect due date for application next season. Coach has offered to have Booster Club do a presentation to the team about the scholarship process and have Q&A time to be sure they understand details.

### **New Items**

- a) Pizza Ranch night in Waukee set for November 4.
- b) Shan is leaving Des Moines. She will be here for camp. How do we replace her work in the Cove during games? Suggestion of sign up for officers and board members to rotate time.
- c) Curtis suggests having another picnic in September. Will discuss more later.
- d) The Bucs organization will pay part of the cost of bags for the players. Denise will order these over the summer to have them ready for next season. Melinda can check with Doug (t-shirt vendor) on new options.
- e) Tammy will check with Plaza Printers about the “fan noisemakers” as an option for next season.
- f) Curtis asked for suggestions on what to improve and how to increase interest in the Booster Club. All member are requested to send ideas to Curtis. Ideas from tonight: schedule road game, have the coach speak to the club, have players stay after radio show to speak to the club, have a raffle at meetings, consider a scholarship for active members children, have a jersey raffle
